The Chairperson of the SLC welcomed the participated members and the special invitees of the Committee. The SLC reviewed and discussed the proposals of Large and Mega projects placed in the SLC on case to case basis. The Chairman requested the representatives of Industrial units to furnish the details of their employees and activities taken up under Corporate Social Responsibility along with photos as the Government intends to showcase it in the departmental website. The chairperson requested the unit holders to speak out if they have any grievances relating to their industries.

The promoter of M/s. Ramabhadra Industries Pvt, Ltd, Talacheruvu (V), Tadipathi (M), Anathapuram District has informed that their proposal for sanction of investment subsidy for their 'wind power' project is pending in CoI as they couldn't produce the registered land sale / lease deed as it is allotted by the Government on tri-party mode between NREDCAP, the developer M/s. Gamesa Wind Turbines Pvt Ltd., (Developer) and them. The Commissioner of Industries directed the JD(II) to send a reminder to the Government for resolving the issue. He has also requested the representative of Registration and Stamps

department who attended the meeting to look into the matter and comply in the next meeting.

The President of M/s. A.P. Spinning Mills Association has stated that their association is very happy because the SLC could able to sanction an amount of Rs.801.61 Crores to the long pending (771) claims, pertaining to (372) Large and Mega projects in the last (5) meetings under the guidance and dynamic leadership of the Commissioner of Industries. He has appreciated the Commissioner of Industries and other Staff for performing fantastic job in achieving this with hard work and dedication. He expressed his pleasure for creating Investor friendly environment through EoDB as it is very encouraging to set up new Enterprises. He also told that a new era has been embarked with the initiatives of the Government.

- The Chairperson requested the SLC members to offer their remarks and suggestions for framing new Infrastructure policy guidelines for mega projects along with safety measures to be taken by the Government in case of non implementation of the unit after availing the incentives under IIDF.
- The SLC observed that the claims are being received without indicating the date of completion of infrastructure component by industrialists and without proper supporting documents. The line departments are denying for mentioning the date of completion of the infrastructure component, executed by Units. Power line component completion can be considered by verifying the date of power release whereas as in case of road, water and other components, there is no evidence about date of completion. The SVC expressed its view to ascertain the date of completion from Chartered Accountant by verifying the date of expenditure and also by obtaining the affidavit from the unit holder. Further it is decided the date of completion of each infrastructure should be before DCP or within 6 months from DCP.
- The SLC discussed the importance of date of completion of infrastructure components and its effect on the eligibility for sanctioning the incentives under IIDF.
- The Chairperson instructed the JD (Infra) to prepare simplified guidelines on IIDF and to place it in next SLC for deliberations and suggestions.
- The Chairperson also directed to take necessary measures for filing and processing of IIDF claims through Information Technology enabled platform with an aim to improve the Ease of Doing Business.
