ORDER:

In the G.O. 1st read above, Government have constituted Group of Ministers (GoM) with the following Ministers to discuss the issues /problems relating to Jute, Sugar, Ferro Alloys and Textile sectors:

- (i) Hon'ble Minister for Finance & Planning, Commercial Taxes, Legislative Affairs.
- (ii) Hon'ble Minister for Panchayat Raj, Rural water Supply, NREGS.
- (iii) Hon'ble Minister for Transport, R&B.

2. In the meeting held on 17.08.2016, the Group of Ministers have discussed various problems/ issues related to Textile Sector and made the following recommendations:

- (A) The units established during IIPP 2010-15 period which completes their five years claim period to consider for claiming power cost reimbursement of two rupees per unit for the remaining five years period restricting the total claim period to ten years(5+5).
- (B) The units established during 2010-15 period which completes their five years claim period including the roll over option period to avail IIPP 2015-20 benefits for the balance period of IIPP 2010-15 is also to consider for claiming their power cost reimbursement at two rupees per unit for the remaining five years restricting the total claim period to ten years(5+5).
- (C) The industrial units shall submit their claim applications before the concerned General Managers, District Industries Centres as per the present guidelines for filing their power tariff reimbursement applications or within six months period from the date of issue of Government orders whichever is applicable.

3. Govt. after careful examination and after following due course of procedure hereby order to extend power incentives to the Spinning/Weaving/Garmenting enterprises/ industries as follows:

Part-A: For the Textile Units commissioned during IIPP 2005-10:

To extend the Incentive of Power Cost reimbursement to the Spinning/Weaving/Garmenting units commissioned during IIPP 2005-10 Policy @ Rs.1.00 per unit for a period of 2 years after completion of 8 years of the claim period. This incentive is also applicable to the units that have already completed 8 years of claim period

Part-B: For the Textile Units commissioned during IIPP 2010-15:

To extend the Incentive of Power Cost reimbursement to the eligible units commissioned during IIPP 2010-15 Policy for an additional period of Five (5) years. The Power cost reimbursement for this additional period will be @ Rs.2.00 per unit. The units established during 2010-15 period that have completed five (5) years period including Roll over option period to avail IIPP 2015-20 incentives for the balance period of IIPP 2010-15, are also eligible for this incentive.

4 . The industrial units shall submit their claim applications before the concerned General Managers, District Industries Centres as per the present guidelines for filing their power tariff reimbursement applications or within six months period from the date of issue of Government orders whichever is applicable.

5. The Commissioner of Handlooms & Textiles, Mangalagiri, Guntur District shall take necessary action in the matter.
